SHOW CAUSE NOTICE U/S 17

WHEREAS, recognition was granted by the Western Regional Committee to the Institutions (as per list enclosed) for B.Ed, M.Ed, B.P.Ed. Course of 1 years duration with an annual intake as per recognition orders.

2. AND WHEREAS, in exercise of the powers conferred by sub-section (2) of Section 32 of the National Council for Teacher Education Act, 1993 (73 of 1993), and in supersession of the National Council for Teacher Education [Recognition Norms and Procedure] Regulations, 2009, the National Council for Teacher Education notified the Regulations, 2014 on 01.12.2014.

3. AND WHEREAS, the institutions submitted a notarized affidavit consented to come under new Regulations for two year B.Ed./M.Ed./ B.P.Ed. course as the case may be (as the list attached) which required additional facilities. The same was permitted to the institution subject to the institution fulfilling following conditions, namely:-

- The institution shall create additional facilities that include (a) additional built-up area, (b) additional infrastructure, (c) additional funds, (d) additional staff as per Regulations, 2014 and inform Regional Committees with required documents by October 31st, 2015.
- II. The applicant-institution for additional unit will be required to submit the required documents such as land documents, Encumbrance Certificate (EC), Land Use Certificate (LUC), Building Plan (BP) and the Approved Staff List in the specified performa available on the website to the Regional Committee in proof of having provided additional facilities before October 31st, 2015. Building Completion Certificate (BCC) may be given along with other documents if available; otherwise it can also be given to the Visiting team at the time of inspection.
- III. The Regional Committees shall arrange for verification of documents, inspection of these premises and check adherence to these conditions by October 31st, 2015. If it is found by the Regional Committee that the institution fails to comply with these requirements, the institutions shall not be permitted to admit students for the academic year 2016-2017.

4. **AND WHEREAS**, the WRC in its 316th meeting held on 27th to 28th Aug & 4th Sep, 2020 considered the matter and decided to issue SCN U/s 17 of the NCTE Act, 1993 to all such institutions of Rajasthan which were issued Revised Recognition orders with a direction to submit compliance to the conditions mentioned / stipulated in the Revised Recognition order issued by WRC-NCTE. Therefore, the institution is required to submit the following documents/information:-

- 1. The Institution is required to submit a notarised copy of valid recognition order /RPRO order and latest affiliation order of the affiliation body.
- 2. The Institution is required to clarify about running of institution at rented premises/private lease/govt lease or land on ownership basis. If the institution running on rented or private lease basis as on date the reason thereof for not shifting the premises to permanent building is required to be submitting by the Institution.
- 3. The institution should note that there should be no change of land and building documents except the addition of built up area in the approved building. Therefore the institution is required to submit land and documents submitted at the time of recognition and the present status of the same.

4. The institution is required to submit an undertaking that there is no charge in the name of Society/Trust(Management) which got the recognition of the institution and now submitting reply of SCN

- 5. Keeping in view the points mentioned above. The institution is required to submit the following documents/clarifications for perusal of the WRC, NCTE-:
 - The institution is required to submit certified copy of land documents issued by concerned Tehsildar /Revenue Officer. (If the same are in Regional Language the institution is also required to submit notarised copy of English version of land documents)
 - ii. The institution is required to submit an attested/notarised copy of Land Use Certificate issued by the Competent Authority.

III. The institution is required to submit a copy of Non-Encumbrance Certificate issued by the Competent Authority. The institution is required

- Iv. The Institution is required to submit an attested/notarised copy of the approved Building Plan (if institution is running more than one Teacher Education programme, it shall be required to submit an exclusive earmarked building plan for each of the recognised Teacher Education programme)
- v. An attested/notarised copy of site plan showing all the plot/Survey No. mentioned in the land documents in one location alongwith land area and built up area.
- vl. The Institution is required to submit an attested/notarised copy of Building Completion Certificate issued by the competent authority.
- vil. Fire Safety certificate issued by the competent authority is required.
- viil. The institution is required to submit Staff list duly approved by the Registrar of the affiliating body as per the prescribed Format. (In case the institution is running more than one teacher education programme, it is required to submit staff list duly approved by the Affiliating body for each of the recognised teacher education programme being run by the Institution.)
- ix. The institution is required to submit original FDRs to the WRC, NCTE The institution is required to submit a "Form A" issued by the respective Bank Manger towards creation of FDR of Rs.7 lakh and 5 lakh, totalling Rs.12 lakh towards Endowment Fund & Reserve Fund into joint account for a duration of 5 years alongwith a copy of the FDRs.
- x. Details of Teacher Education programme (s) being run by the Institution in the same campus

 - c. Status of Management at the time of recognition and its present status

In case of change of land & building or the Management at the time of recognition and thereafter the institution is required to specify the reason thereof with approval of the WRC, NCTE.

Note-

The Institution is required to note the following:-

- i. in case the Institution is already issued Show Cause Notice by the WRC, NCTE the reply of the san is also to be submitted by the institution.
- II. In case the recognition of the institution is already refused/withdrawn or not continued then the operation of notice be treated as cancelled.

NOW THEREFORE, the institution is required to submit the representation/compliance 5. accompanied with an affidavit from the authorized representative of the Management. The representation along with an affidavit must reach this office within the time specified at the end.

In case the reply submitted is incomplete or factually incorrect or not received in this office 6. within 30 days of this notice, then it shall be treated as incomplete reply to the terms of this notice and action as deemed appropriate as per NCTE, Act, Rules and Regulations shall be taken.

Your reply shall reach this office within stipulated time through through Courier / Registered 7. AD/ Speed Post only. Applicant are not required to personally visit the RC Office for any reason whatsoever.
